# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.orangefloat.com, and Orange Float, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Orange Float, LLC include www.orangefloat.com and Orange Float. The Orange Float website is a media production and design site. By using the Orange Float website, you consent to the data practices described in this statement.

## **Collection of your Personal Information**

In order to better provide you with products and services offered, Orange Float may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title

If you purchase Orange Float's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Orange Float may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender
- Religion

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or non-personal information in the future.

### **Use of your Personal Information**

Orange Float collects and uses your personal information to operate and deliver the services you have requested.

Orange Float may also use your personally identifiable information to inform you of other products or services available from Orange Float and its affiliates.

## **Sharing Information with Third Parties**

Orange Float does not sell, rent or lease its customer lists to third parties.

Orange Float may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Orange Float, and they are required to maintain the confidentiality of your information.

#### **Use of Cookies**

SSL Protocol
